Duties of Office

Treasurer: The Treasurer shall have responsibility for keeping full and accurate accounts of all receipts and disbursements, prepare and submit to the membership an annual report of the financial position and result of operations, and are prepared to present an update on finances of the Association at any special meeting of the Association and Board of Directors.

At-Large Board Members: The At-Large Board Members shall help carry out the provisions of RNA's official Bylaws and Covenants.
